To use the Get Transcript Online tool, the user must have (1) access to a valid email address, (2) a text-enabled mobile phone (pay-as-you-go plans cannot be used) in the user's name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgage or auto loan). The transcript displays online upon successful completion of the IRS's two-step authentication.
- <u>Automated Telephone Request</u> 1-800-908-9946. Transcript is generally received within 10 business days from the IRS's receipt of the telephone request.
- <u>Paper Request Form</u> IRS Form 4506T-EZ or IRS Form 4506-T. The transcript is generally received within 10 business days from the IRS's receipt of the paper request form.

<u>AMENDED</u> Tax Return Filers: If you (or your spouse, if married) file, or will file, an amended 2022 IRS tax return, you must provide a **2022 IRS Tax Return Transcript** <u>and</u> a signed copy of the **2022 IRS Form 1040X**, "Amended U.S. Individual Income Tax Return".

<u>FOR CHANGES IN TAX FILING/MARITAL STATUS</u>: If you and your spouse filed separate 2022 IRS income tax returns, the IRS DRT cannot be used and the 2022 IRS Tax Return Transcript(s) or a signed copy of the 2022 income tax return and applicable schedules must be provided for each.

FOR VICTIMS OF IRS TAX-RELATED IDENTITY THEFT: If you (and/or your spouse, if married) were the victim(s) of IRS tax-related identity theft, you must provide a 2022 Tax Return DataBase View (TRDBV) transcript obtained from the IRS, or if unable to obtain a TRDBV, an equivalent document provided by the IRS or a copy of the signed 2022 income tax return and applicable schedules the individual filed with the IRS; and a statement signed and dated by the tax filer indicating that they were a victim of IRS tax-related identity theft and that the IRS is aware of the tax-related identity theft.
